RECEIPTS WILL NOT BE MAILED IF AN ENVELOPE IS NOT PROVIDED.



Payments may also be deposited in the mail slot at the Town Hall, located under the second window to the right of the main doors.

There will be a \$30.00 fee charged for any check returned for insufficient funds.

ESCROW PAYMENTS: Be sure to sign your escrow check if it is made payable to you **AND** the Town of Addison. **Checks MUST BE ENDORSED by the owner(s) before mailing to the Treasurer.** Make sure your lending institution has the proper mailing address. Failure to have the correct address may result in a delay in payment. If the escrow check is greater than the amount of the bill, a refund check will be mailed within seven (7) days. Refunds of \$2.00 or less will not be refunded unless specifically requested.

DOG LICENSES

A SELF-ADDRESSED, STAMPED ENVELOPE MUST BE PROVIDED



All dogs over five (5) months of age require licensing by April 1st. An application must be filled out completely for each dog. Proof of rabies vaccination and expiration date is required at the time of licensing. No licenses will be mailed without a return envelope. (One envelope is sufficient for both taxes and dog tags)

There is a \$5.00 late fee, per dog, if not licensed by April 1st.
